These Terms of Service and Privacy Policy govern your participation in our online fitness, nutrition, and lifestyle coaching programs, mobile applications, and online services hosted via **theinfinitepowerofgoals.com**. By enrolling in our programs or purchasing our services, you ("Client," "you") agree to be bound by the terms outlined herein.

PART I: TERMS OF SERVICE

1. Overview of Coaching Services

Infinite Goals LLC provides custom macro/nutrition meal planning, customized exercise protocols, and daily tracking/accountability coaching via digital platforms. Coaching programs are provided on a recurring subscription or program term basis. Coaching services are educational and instructional in nature.

By executing this agreement, you confirm that you are in good physical health and free from any medical condition that would prevent your safe participation in an intensive weight loss or athletic conditioning program. You expressly assume all risk of injury, health complications, or physical harm associated with your participation.

3. The 200% Guarantee ("Double Your Money Back") Terms & Conditions

Infinite Goals LLC offers an exclusive performance-based refund policy: the **200% Double Your Money Back Guarantee**. Because results require absolute adherence, strict compliance verification standards apply. To qualify for a double refund under this guarantee, the Client must satisfy **ALL** of the following conditions without exception during the 90-day program quarter:

QUALIFICATIONS FOR THE DOUBLE MONEY BACK GUARANTEE

1. **Daily Check-In Requirement:** Client must submit the official daily digital check-in form in the Client Portal at theinfinitepowerofgoals.com every single calendar day (12:00 AM – 11:59 PM local time) for 90 consecutive days. Missing even one daily check-in forfeits eligibility.
2. **100% Workout Adherence:** Client must complete 100% of assigned workout routines as prescribed in the client app, logged in real time with exercise weights, reps, and timestamped video verification or smartwatch workout logs.
3. **100% Meal Plan Adherence:** Client must adhere 100% to prescribed caloric and macronutrient targets. Meals must be logged daily with photo proof and weighed metrics via our macro-tracking app. Deviation exceeding +/- 3% on daily calories or macronutrient split forfeits eligibility.
4. **Weekly Progress Verification:** Client must upload weekly progress photos (front, side, back views) with a newspaper/timestamp verification, weekly body weight logs (weighed first thing in the morning), and waist circumference measurements every 7 days.
5. **Coach Directives:** Client must implement and follow all bi-weekly or custom adjustments communicated by their designated Infinite Goals coach within 24 hours of notice.

3.1 Result Thresholds & Claim Evaluation
